AMY B. BARNHART MEDIATION SCHOLARSHIP PROCEDURES

A. ELIGIBILITY

1. Applicant must be a candidate for graduation from a high school within the Conflict Resolution Center service area which includes Alleghany, Bath, Bedford, Botetourt, Buena Vista, Craig, Floyd, Franklin, Henry, Highland, Lexington/Rockbridge, Montgomery, and Roanoke counties as well as the cities of Roanoke, Salem, and Martinsville.
2. Applicant must have at least 2.5 Grade Point Average.
3. Applicant must have been accepted by an accredited college or university approved by the scholarship committee.
4. Applicant must submit the attached questionnaire signed by a guidance counselor validating the information regarding graduation, college acceptance, and GPA.
5. Applicant must submit one additional letter of recommendation from someone other than a relative with knowledge of his/her mediation skills.

B. FINANCIAL CONSIDERATION

1. The total value of the scholarship is \$500.00
2. The scholarship is awarded in the form of a check from the Conflict Resolution Center made payable directly to the recipient's approved school.
3. The award is to be used to pay direct educational expenses of the recipient.

C. PROCEDURES FOR SELECTING RECIPIENTS

1. Recipient shall be chosen by a committee.
